
TENDER NOTICE

Sealed tenders based on item / percentage rates above or below **MRS 2nd Bi –Annual Period (1st July 2019 to 31st December 2019** are hereby invited for below mentioned work from the contractors / firms which have been registered / renewed with the Pakistan Engineering Council for current financial year 2019-20 and are enlisted with HUD & PHE Department & MDA in the field of road/ civil work for respective categories. Tender documents can be obtained from office of the Executive Engineer-III, MDA against written request accompanied with original and attested copies of enlistment / upto date renewal letter, PEC licences, HUD&PHE department, renewal letter authority letter on pad form of contractor / firm, identity card of contractor / Managing partner of the firm along with power of attorney, partnership deed and on payment of prescribed tender fee etc. Tenders should accompany earnest money @ 3% of Estimated Price in the shape of deposit at call in favour of Director Finance & Administration MDA Multan from any scheduled bank. Tender rates and amounts should be filled in figures as well as in words and tenders should be signed as per general directions given in the tender document. No rebate on tendered rates will be acceptable.
